# COVID19 Update August 2021 - June 2022

- RSU 12 continued to follow the plan developed in August 2020 which made in-person learning a priority if possible and safe.
- RSU 12 students in RSU 12 schools received in-person learning.
- Schools have been opened all year. No school closure or remote learning.
- Individual students had to quarantine if COVID positive.
- Close contacts did not have to quarantine because we were a universally masked school district.
- As of February 28th, masks are now optional







#### RSU 12 Total Valuation - 3 year Rolling Average




